WELCOME TO RHYOLITE NV

A Historic Mining District from the early twentieth century.

Also well known Ghost Town located in rural Nye County Nevada.



BRIEF HISTORY OF RHYOLITE NV



- Located 120 miles NW of Las Vegas, NV.
- Started in 1905 as a prospecting camp for gold mining.
- The Montgomery Shoshone Mine was the main investment and by 1907 the town was electrified!
- Peak population was 3,500 to 5,000 in 1908.
- Decline was rapid, the San Francisco Earthquake and financial panic made it difficult to raise development capitol. By 1910 the mine was operating at a loss.
- The town of Rhyolite's population was falling, by 1920 it was close to zero.
- Now one of the most photographed ghost towns in the west, managed by the BLM.

The Cook Bank Building, 1908 (left) and 2009 (right)

- After bust, buildings crumbled and materials were salvaged for nearby towns.
- Some entire structures moved to Beatty

- Stone and concrete structures historically significant
- Popular with photographers and filmmakers



SITE MANAGEMENT

• Transferred to BLM in 1990s

- Safety and security risks
- Financial burden

- BLM priorities ...
 - Stabilize the structures
 - Work with the County

- County, city, nonprofit and other agency partners share an interest in Rhyolite
- No current formal partnership with the Friends Group, working in Rural areas adds to outreach difficulties.
- BLM saw needs partner could help fill
 - Site management
 - Promote tourism
 - Raise funds

- Nonprofit
- Works with the town of Beatty and County
- Focus on history and tourism
- Small, local residents
- Connection to Western Museum



DEFINING OUR ROLES AND RELATIONSHIP

- Historic and current relationship
- Common interests, beyond "the town"
- What each partner brings to the table
- What each partner sees as a priority
- How we work and who we work with
- Clearly define benefits to the agency, resource, partners
- Clearly explain guiding agreements, frameworks, authorities.

MEETING AND PARTNER REALITY

• Friends group was

- Passionate about the town
- Advocating with the County and city
- Content with their role
- Not interested in a formal partnership with BLM
- Small capacity



PUSHING BOULDERS

LESSONS LEARNED

- Friends groups may not be structured in a way that lends itself to formal partnership with BLM
 - Capacity and sustainability of their organization
 - Interests and historic role
 - Differences in how we work
 - Expectations about who is responsible for what
 - Not all friends groups are the same
